


BIOEAST Initiative

Central-Eastern European Initiative for Knowledge-based Agriculture, Forestry and Aquaculture in the Bioeconomy

Shared strategic research and innovation framework for working towards the development of sustainable bioeconomies in Central and Eastern Europe (CEE).

Why BIOEAST: Low performance of knowledge-based agriculture, aquaculture and forestry in the bioeconomy, significant internal disparities in terms of research and innovation performance, and low participation of CEE region in H2020.

How could Commission help the process of better uptake of bioeconomy at national level?

- Information campaign aimed on promotion and explanation of renewed EC Bioeconomy Strategy oriented on regional (national) stakeholders in cooperation with national contact points for national/regional bioeconomies.
- Part of the materials (summary, infographics, bioeconomy fiche) should be translated into national languages in order to be better understood by all stakeholders (SMEs, enterprisers, public, students,)
- The support in promotion of best practices and experiences on national level
- Research and innovation calls oriented on topics related to bioeconomy in the regions with "less mature bioeconomy"
- The emphasize and support inclusion of bioeconomy topics/themes (in the Strategic plans of the CAP after 2020, Rural Development Programmes, programmes oriented on quality of life or other relevant programmes)
- To ensure a greater involvement of all the Member States and stakeholders at the EU-level bioeconomy processes we invite the Commission to strengthen the bioeconomy policy governance and the cooperation with national policy makers. It is important to provide all stakeholders in all Member States with up-to-date information.
- We believe that in cooperation with BioEast would help to develop its own bioeconomy strategy.
- information seminars demonstrating both the need and advantages of having efficient bioeconomy strategy directed to various bioeconomy value chains and in other hand providing support of building expertise and information based on the experiences and problems from other member states already advanced in bioeconomy.
- To help by putting additional focus on bioeconomy in the formulation of policies
- To extend emphasis and support the bioeconomy in Rural Development Programmes



Building up the capacities in the public administration for bioeconomy strategy development

- 1. Should be tailor-made to address the country's needs
 - At administrative level
 - At policy decision maker level
- 2. Should provide a unique combination of expertise (from the European Commission, EU countries, international organizations and/or the private sector)
- 3. Should strengthens the cross ministerial administrative capacity of an EU country to design and implement bioeconomy strategy building

GAP:

There is a mismatch in knowledge and perceived importance:

- 1. between the different ministries
 - On policies, priorities, strategies and action plans
- 2. Between the sectors:
 - Silo-based approach
- 3. Between the level of administration and political decision makers:
 - Level of importance



PSF/ each country / first steps

- 1. Bringing together a group of administrators from different ministries at the same level of knowledge about all the current EU sustainability and climate neutrality guidelines concerning the bioeconomy strategy development.
- 2. Bringing together a group of policy decision makers from different ministries and providing with good examples and current EU policy guidelines on overarching bioeconomy policy issues.
