






Examples of research and innovation activities

- Improve long-term durability and outdoor performance of wood-based products by developing new and sustainable protective treatments and design solutions
- Research new, integrated smart functions such as photovoltaic and heat-conversion properties, and biosensors that provide provenance and traceability



Create opportunities for high-impact projects! Moving the challenge from business to research

#### **Specific Business Challenges**

- 1. Ban on toxic wood-treatment chemicals
- 2. Weathering of wood products favours stone, plastic and tropical timber

#### **Innovative Research activities**

1. Enzymatic degradation of cellulose fibres creates nano-cellulose which is light, durable and stronger than steel

#### **Specific Research Challenges**

- 1. high viscosity of nano-cellulose suspension
- 2. Long-term behaviour of NFC-reinforced glues and coatings

#### **Business opportunities**

Nano-cellulose might be used in wood coatings to achieve;

- 1. super-durable v ood products
- 2. Improved dimensional stability
- 3. Electronic-like properties on wood surface
