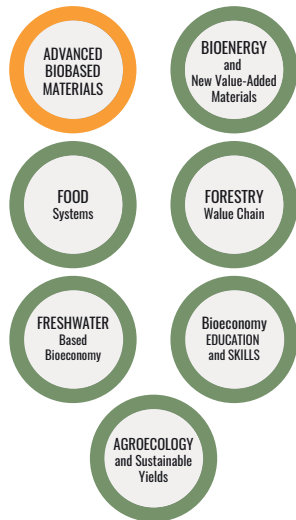

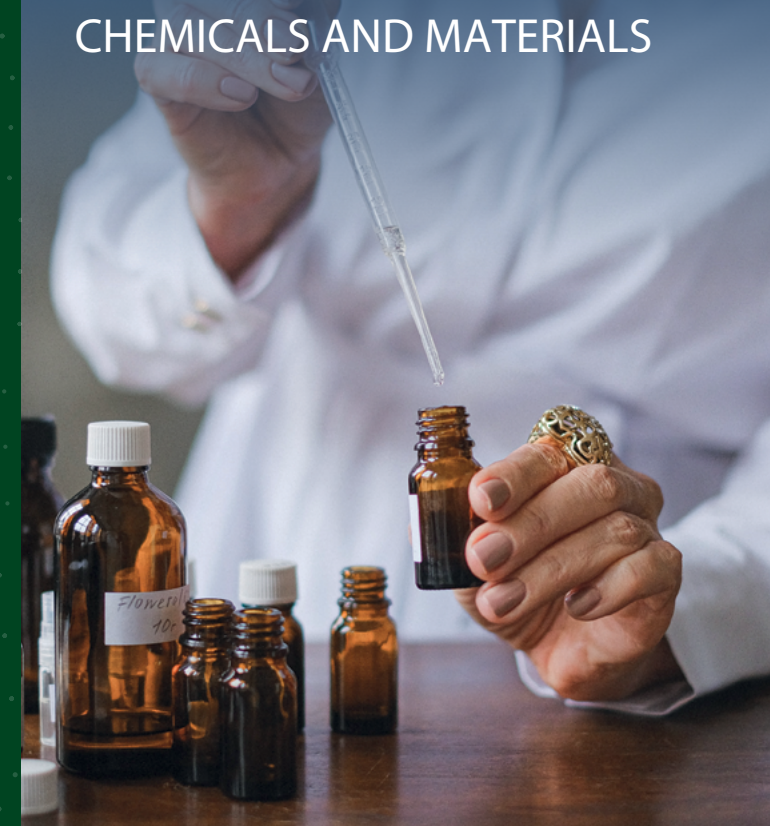

The **mission** of the Thematic Working Group Advanced Bio-based Chemicals and Materials (BC TWG, founded June 2021) is to facilitate the development of a circular bioeconomy in the countries they represent, with a distinct focus on fully or partially bio-based chemicals and materials.



To achieve this, the TWG set out to connect various stakeholders on all levels and collect existing information and technologies to tailor the macro-regional Strategic Research and Innovation Agenda. ## Thematic Strategic Research and Innovation Agenda – Main focus areas:

- Chemical and enzymatic transformation of biomass.
- Production of bioactive compounds and biomaterials.
- Innovative, high-value biobased products
- Blue economy for the production of sustainable biochemicals.

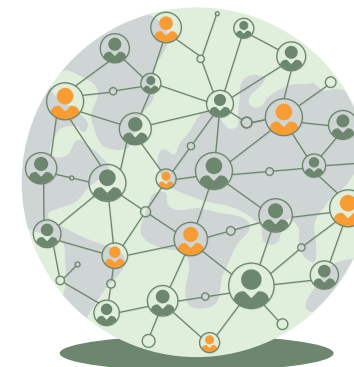
